These risks include but are not limited to the risk of illness, falls, bites, scratches, and personal and property injury and actual and consequential damages to me or my animals or both. Further, in consideration of my participation in Shadow Dog Sports Barn Hunt Trials, I, for myself, and on behalf of my heirs, assigns, and personal representatives, hereby release and hold harmless Shadow Dog Sports, Greater Columbia Obedience Club, its members, volunteers, agents, officers, employees, sponsoring agencies, sponsors, advertisers, owners, or lessors of any premises used to conduct Shadow Dog Sports Barn Hunt Trials. I/we certify that I/we do not, to my/our knowledge, have COVID-19 at the time of attending these Barn Hunt Trials. Nor have I/we knowingly been in contact with or exposed to any person with COVID-19 within the past 14 days. I/we have not been told to isolate or quarantine. I/we are not awaiting the results of a COVID test. If I/we have been diagnosed with the virus or have had virus-like symptoms but no formal diagnosis, I/we certify that I/we have been released by government officials and/or my/our health care providers to resume all activity with no limit, and can produce results from a positive antibody test on request, or have had no symptoms for a minimum of 14 days prior to the Barn Hunt Trials. I/we understand that we have entered and are competing at these Barn Hunt Trials entirely at my/our own risk and take full responsibility for my/our own health and safety during these Trials. I/we pledge to follow all Barn Hunt Association and Shadow Dog Sports trial rules and requirements to mitigate any possibility of infecting others or becoming infected. I/we understand that mask wearing is not required but may be worn if I/we decide to do so. I/we will cooperate with any health department and/or State/Local guidelines that have jurisdiction in the area in which the trials are taking place. If COVID conditions change after my entry and mask become required, I will follow those recommendations. We will have qualifying, placement, and new tittle ribbons as well as High in Class rosettes for A classes and Master B classes.

As allowed by Barn Hunt Rules Move ups/down/lateral will be allowed Trial -to-Trial

From Aiken, SC, or Augusta Ga. via I-20 E

Take the I-26 E exit, EXIT 64A, toward Columbia. Remain left on I-126E/Elmwood Ave. (DO Not continue right on I-26E towards Charleston) Turn Right on Assembly St. Go 2.2 miles (as you pass the Fair Grounds on your right Assembly St becomes George Rogers Blvd.) You will continue straight and stay to the right as you curve pass the fairgrounds then get in the center lane. Fairgrounds will be on your right and stadium will be on your left. At next intersection go straight. This is South Stadium Drive. We are in the last paved parking lot on the right. Building is last warehouse in the parking lot.

From Spartanburg/Greenville via I-26E

As you are approaching Columbia Take exit 108B to merge onto I-126 E toward Downtown Columbia. Remain left on I-126E/Elmwood Ave. (DO Not continue right on I-26E towards Charleston) Turn Right on Assembly St. Go 2.2 miles (as you pass the Fair Grounds on your right Assembly St becomes George Rogers Blvd.) You will continue straight and stay to the right as you curve pass the fairgrounds then get in the center lane. Fairgrounds will be on your right and stadium will be on your left. At next intersection go straight. This is South Stadium Drive. We are in the last paved parking lot on the right. Building is last warehouse in the parking lot.

From Charlotte via I-77S

Stay on I-77S to Exit 5, Bluff Road, take right off exit (Bluff Road). Stay on Bluff Road to George Rodgers Blvd./S. Stadium Road (Williams Brace Stadium will be on the right) turn left onto South Stadium Rd. We are in the last paved parking lot on the right. Building is last warehouse in the parking lot.
