Entries are accepted based on the **date payment is received** either via online payment (no charge) or check received via mail. Based on the response to our July 2023 Trial, we advise on-line entry and payment. There is a place on the on-line entry form to mark if you plan to use Rattie Bucks towards your entry fee. Marking “Yes”, temporarily holds your entry for 24 hours to allow you time to complete the process below.

How to use your Rattie Bucks when Registering on-line and still secure your spot

Since we tend to fill soon after opening and the mail service in this area is slow, we encourage online registration but have a solution that will allow you to reserve your spot and use your Rattie Bucks

Once you complete your registration(s) you will receive an invoice asking you to pay.

3. Take a picture of all the bucks you want to use and either text or email them to me.

5. I will manually adjust the invoice and send you an adjusted invoice you can pay online.
6. Once I send the new invoice, please pay it promptly to reserve your spot. If we are full and have a waiting list, your spot is still reserved for 24 hours after the adjusted invoice is sent to you.
