Blinds will be in a separate ring, separated by barriers preventing a visual view of the ring where tests are held, up to 6 exhibitors in blind. Master Blind will have 5 exhibitors.

Lunch will be provided for the judge, stewards, and trial committee. We will have a list of nearby places to eat, or you may bring your own lunch.

Barn Hunt Grounds include the Building, Parking Lot, including the Grassy Areas on the edge of the parking lot. We ask that all exhibitors clean up after their dogs. Dispose of your poop bags in the dumpsters located in the parking lot.

We are following the CDC COVID recommended precautions. Please bring your mask. They will be required in the blinds and possibly any time you are indoors, depending on CDC recommendations at time of the trial. Entering this event online means that you have read, understand, and agree to abide by the Shadow Dog Sports, GCOC and COVID Waivers.

#### From Aiken, SC via I-20 E

Take the I-26 E exit, EXIT 64A, toward Columbia. Remain left on I-126E/Elmwood Ave. (DO Not continue right on I-26E towards Charleston) Turn Right on Assembly St. Go 2.2 miles (as you pass the Fair Grounds on your right Assembly St becomes George Rogers Blvd.) You will continue straight and stay to the right as you curve pass the fairgrounds then get in the center lane. Fairgrounds will be on your right and stadium will be on your left. At next intersection go straight. This is South Stadium Drive. We are in the last paved parking lot on the right. Building is last warehouse in the parking lot.

#### From Spartanburg/Greenville via I-26E

As you are approaching Columbia Take exit 108B to merge onto I-126 E toward Downtown Columbia. Remain left on I-126E/Elmwood Ave. (DO Not continue right on I-26E towards Charleston) Turn Right on Assembly St. Go 2.2 miles (as you pass the Fair Grounds on your right Assembly St becomes George Rogers Blvd.) You will continue straight and stay to the right as you curve pass the fairgrounds then get in the center lane. Fairgrounds will be on your right and stadium will be on your left. At next intersection go straight. This is South Stadium Drive. We are in the last paved parking lot on the right. Building is last warehouse in the parking lot.

#### From Charlotte via I-77S

Stay on I-77S to Exit 5, Bluff Road, take right off exit (Bluff Road). Stay on Bluff Road to George Rodgers Blvd./S. Stadium Road (Williams Brace Stadium will be on the right) turn left onto South Stadium Rd. We are in the last paved parking lot on the right. Building is last warehouse in the parking lot.
